By signing this Release and Hold Harmless Agreement ("Agreement"), I, _____, the undersigned parent or guardian of _____ ("Participant"), acknowledge that equine assisted activities, therapeutic and pleasure riding are dangerous activities that may result in injury (including death) to Participant, or result in damage to Participant's personal property. With this knowledge, in consideration for the services of Karen Slayton (Karen Slayton, independent contractor Path Intl. Certified Riding Instructor, is referred to herein as "Karen Slayton"), and as inducement for Karen Slayton to provide equine assisted activities, therapeutic and pleasure riding to Participant, and/or to assist in providing equine assisted activities to Participant, I hereby waive, release, discharge and hold harmless Karen Slayton, and her volunteer assistants, their heirs, executors, administrators, successors or assigns, from any and all liability for damages sustained by Participant, Participant's family, any animal owned or controlled by Participant, or for any item of personal property under Participant's dominion and control.

Without limiting the generality of the above, I hereby waive and release Karen Slayton, and her volunteer assistants, for liability based on the active or passive negligence of Karen Slayton. I hereby agree to indemnify and hold harmless Karen Slayton, and her volunteer assistants, for any claims which may be made against them, including attorney's fees and costs of suit, in any action based upon or arising from Participant's acts or omissions, or the actions of any animal within Participant's control. This release extends to all claims, whether presently known or unknown. I hereby expressly waive any benefits I or Participant may have pursuant to Section 1542 of the California Civil Code relating to the release of unknown claims, which provides: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favour at the time of executing the release which if known by him must have materially affected his settlement with the debtor."

For and in consideration of Participant's participation in equine assisted activities, therapeutic and pleasure riding with Karen Slayton, I state that I have read the waiver, release and hold harmless Agreement written above and I expressly agree that the terms and conditions of said waiver, release and hold harmless Agreement shall apply to and be binding upon me and Participant (my minor child). I further warrant I have health insurance for said Participant.
